CONSTRUCTION ACTIVITY REMAINED STRONG THROUGHOUT FISCAL YEAR 2018-19

Construction activity in Los Angeles finishes strong for FY 2018-19 as the development community, in collaboration with the City, has continued efforts to expand commercial and housing stock including affordable housing for low-income families and the homeless. The passage of Measure HHH provided a 1.2 billion bond measure for the construction of 8,000-10,000 affordable housing units for the homeless and those considered at-risk of being homeless. With the passage of Measure JJJ, the City has been developing Transit Oriented Communities and Districts (TOC and TOD) through the TOC/TOD Affordable Housing Incentive Program which provides affordable housing near mass transit. Submittals for plan check and permit issuances for these types of housing projects have been processed by the Los Angeles Department of Building and Safety (LADBS) on a weekly basis. In 2013, Mayor Garcetti set a goal to permit 100,000 housing units (12,500 units on average per year) by 2021. At the close of FY 2018-19, a total of 100,405 new housing units have been permitted since 2013, achieving 100.4% of the Mayor's goal with 24 months—or 25% of the time—remaining. Another priority for the City is the renovation of LAX, which is undergoing a large-scale \$14 billion modernization project to elevate the passenger experience, enhance safety, and increase business opportunities. These projects show the Department's commitment in assisting the development community in building projects that contribute to the growth of the City.

HOUSING HIGHLIGHT

New TOC Permanent Supportive Housing in South Los Angeles

The "Residences on Main" broke ground approximately one week after being issued a permit on April 5, 2019, for a new permanent supportive housing project located at 6901 S. Main St. in South Los Angeles. The current site was a vacant city-owned parcel that will be developed into a four-story apartment building that will provide 100% permanent supportive housing to very low-income families and Transition Aged Youth (TAY) experiencing homelessness. The development will consist of 49 low-income units with 25 units for TAY, 24 units for families,

and one manager's unit. The property will also feature several amenities including a large community garden, central courtyard, laundry facilities, community room, computer lab, and parking for 23 vehicles. Additionally, the site will provide social service components comprising of case management, service coordination, and direct support services including linkage to educational support programs, enrollment in school and/or vocation programs, and subsidized child care. The Tier 2 Transit Oriented Community (TOC) project will be located within 1,500 feet of the Metro Broadway/ Florence Avenue bus station, which serves multiple Metro bus lines and the Dash Chesterfield Square line, making public transportation easy and convenient for future residents. The total permit valuation for this project is \$15.0 million.

LAX Renovations Underway

Development ensues at LAX as several permits were issued for renovation purposes in the past quarter between April 1, 2019 and June 30, 2019. Angelinos can expect a

significant revamp of the airport's existing structures as part of LAX's multi-billion dollar modernization project. Permits issued will alter Terminals 2, 3, and 4 by relocating passenger boarding bridges, adding a boarding corridor, adding a new terminal vertical core that will support a new pedestrian bridge, and tenant improvements that will include a new premier lounge, kitchen, and remodeling an elevator lobby. All planned upgrades are intended to help mitigate traffic, improve operational flow, and ensure traveler safety by integrating more reliable, efficient, and sustainable energy saving technology. The total valuation for the relevant permits issued is \$740,550,300.

Affordable/Supportive Housing

The affordable housing project previously described is only one of many projects being developed geared towards providing assistance to low-income individuals and families.

New LADBS ePlanLA Webplatform

On June 27th, LADBS launched ePlanLA, an online permitting system for a select group of permits that require plan checks.

The system offers customers a convenient, secure, and timesaving method to apply for a permit and submit plans online. Customers follow a six-step process from submission for plan check to permit issuance via an online account.
