EXAMINATION INFORMATION
JOURNEYMAN ELEVATOR MECHANIC

DUTIES

Installation, construction, repair, maintenance, alteration and replacement of any mechanical or electrical device related to elevators, moving stairways, moving sidewalks or ramps, dumbwaiters, manlifts, private residence elevators, inclined lifts, wheelchair lift, inclined stairway chairlifts, vertical reciprocating conveyors or related devices governed by the Los Angeles City Elevator Code.

REQUIREMENTS

Three years experience in the above duties as helper or apprentice to a Registered Journeyman Elevator Mechanic within the elevator industry. One of the following verification of experience shall be submitted with your application:

1. A signed, written verification of experience from your previous or current employer on their company letterhead; or
2. A copy of your current Certified Competent Elevator Mechanic (CCEM) Certification issued by the State of California; or
3. A signed, written verification of experience from the International Union of Elevator Constructors on their letterhead, if applicable.

ANNUAL RENEWAL FEE: \$27.50

SCOPE

The examination for Journeyman Elevator Mechanic consists of questions on the Los Angeles City Elevator Code, California State Elevator Safety Orders, a general knowledge of the Los Angeles Electrical Code in relationship to elevators, and a general knowledge of the equipment listed above.

PASSING SCORE:

70% is the minimum passing score for each part. The score is compiled from two parts (one part written-one part oral). Applicant must pass the written part before oral will be given.

RE-EXAMINATION

Applicants who fail to pass their first examination are entitled to a second examination to be taken not less than 4 weeks after the previous examination. No additional fee is required for the second examination. Applicants who fail to pass the second examination are required by Ordinance to wait 6 months thereafter before they may file another application for the examination, at which time a new application and filing fee is required

RENEWAL

The Journeyman Elevator Mechanic license expires one year from the date of issuance. It may be renewed from year to year by the payment of the annual renewal fee within 30 days after the expiration date, or within 12 months by payment of the renewal fee plus 10% renewal fee for each month after the first.

A VALID WORK I.D. (WITH PICTURE) OR DRIVER'S LICENSE WILL BE REQUIRED WHEN APPLICANTS APPEAR FOR THE EXAMINATION.
