- (4) Smoke alarms or smoke detectors shall be installed a minimum of 20 feet horizontal distance from a permanently installed cooking appliance.

 - EV Ready Thirty (30) percent of the total number of parking spaces shall be equipped with low power Level 2 EV charging receptacles. For multifamily parking

- Multifamily dwellings, hotels and motels and new residential parking facilities with 20 or more dwelling units or sleeping units/guest rooms shall comply with the following: (LAGBC 4.106.4.2.1 (1)) a label stating "EV CAPABLE" shall

 - b. EV Ready Thirty (30) percent of the total number of parking spaces shall be equipped with low power Level 2 EV charging receptacles. For multifamily parking facilities, no more than one receptacle is required per dwelling unit when more than one parking space is provided for use by a single dwelling unit. (LAGBC 4.106.4.2.1(2))
 - c. EV Charger Five (5) percent of the total number of parking spaces shall be equipped with Level 2 electric vehicle charging stations. Where common use parking is provided, at least one EV charger shall be located in the common use parking area and shall be available for use by all residents or guests. (LAGBC 4.106.4.2.1(3))
 - d. When an Automatic Load Management System (ALMS) is used:
 - The electrical system and any on- site distribution transformers shall have sufficient capacity to deliver at least 3.3 kW simultaneously to each EV charging station (EVCS) served by the ALMS.
 - The branch circuit shall have a minimum capacity of 40 amperes and installed EVSE shall have a capacity of not less than 30 amperes.
 - ALMS shall not be used to reduce the minimum required electrical capacity to the required EV capable spaces.
 - One in every 25 charging spaces, but not less than one, shall also have an 8- foot (2438 mm) wide minimum aisle. (4.106.4.2.2.1.2)
- 4. The service panel or subpanel circuit directory shall identify the overcurrent protective device space(s) reserved for future EV charging purposes as "EV CAPABLE" in accordance with the California Electrical Code_

(93.0207, LAGBC 4.106.4.2.4, 4.106.4.2.1)

When only one EV space is required, provide a 208/240 V dedicated branch circuit and a 1"conduit (terminated to a j-box, listed cabinet or enclosure). The panel shall have adequate capacity for the installation of at least the level 2 electric vehicle supply equipment (EVSE). (LAGBC 4.106.4.2.3(1))

 When multiple charging stations are required, plans shall indicate the proposed type and location of EVSE and also include raceway method(s), wiring schematics and electrical calculations to verify that the electrical system has sufficient capacity based upon a 40 Ampere minimum branch circuit to simultaneously charge all electric vehicles at all designated EV charging locations. ____ (LAGBC 4.106.4.2.3(2))

NON-RESIDENTIAL BUILDINGS:(Applicable to new construction)

- When an Automatic Load Management System (ALMS) is used, Each EVSE controlled by an ALMS shall deliver a minimum 30 amperes to an EV when charging one vehicle and shall deliver a minimum 3.3 kW while simultaneously charging multiple EVs.
- 5. Except for emergency lighting, exempted luminaires under the provisions of section 147 of the California Energy Code, college campus lighting requirements for parking facilities and parkways per section 91.1205.6 of the Los Angeles Building Code, building facade meeting the requirements in Table 140.7-B of the California Energy Code, and custom lighting features as allowed by the local AHJ as permitted by section 101.8 of the building code, outdoor lighting systems shall be designed and installed to comply with the following: _______ (LABGC 5.106.8)
