CERTIFIED WELDER EXAMINATION INFORMATION

CERTIFICATION REQUIRED

All welding as per Code Section 91.2204.1, except when performed at the shop of an approved fabricator, shall be done by operators certified by the department for the type of operation involved in accordance with the provisions of Section 91.1705.2.2.1.3. of the Los Angeles Municipal Code.

A. REQUIREMENTS FOR CERTIFICATION

- 1. Complete the Trade License application. Applications expire six (6) months from the cashier's validation date. If the examination is not completed within that time, a new application must be filed and new fees paid.
- 2. Provide a current 2" x 2" full face color passport type photograph taken within one year of the date of application.
- 3. Pay the examination application fee of \$54.50
- 4. Pass the Department virtual examination.
- 5. Pass the performance test at a Los Angeles City approved testing facility.(See link on the following page) Separate additional charges by the approved testing agency conducting the qualification performance tests will apply. Contact the testing agency for their fees.

B. AFTER PASSING VIRTUAL EXAMINATION

- 1. Submit performance test results <u>IN A SEALED ENVELOPE</u> from a Los Angeles City approved testing facility. Performance test results are valid for one (1) year from the date of issuance.
- 2. Pay the required fee of \$65.40, and submit your performance test results within one (1) year from the date you passed your virtual exam.

C. EXAMINATION

- Schedule:The examination will be conducted on Saturdays by appointment
only. All applicants will be notified of appointment date by phone
then e-mail.
 - Time/Location: Location: Google Meet. Examination time will be shown in e-mail.
 - Scope: Examination will consist of open and closed book segments. <u>Applicants must bring the appropriate Structural Steel Welding</u> <u>Code published by the American Welding Society (AWS) covering</u> <u>the scope of their examination</u>. (See Required Code Books for current editions)
 - **Fees:** \$54.50 examination application fee. An additional \$65.40 is due upon passing. A separate application, fee and examination is required for each category the applicant desires to be certified for. A three-year renewal of \$119.90 is charged for renewal of each category certified except for semi-automatic.

Minimum score of 70% is required for passing the virtual examination. Applicants will have one opportunity to pass the virtual exam per application.

(Any person with a current welders certification, will not be eligible to take the Departmental virtual examination for that particular discipline.)

Applicants seeking Tubular Structures certification must have a SSW certification before acquiring a Tubular Structures certification. (Tubular Structures certification is added to your SSW certification.)
