Description of Project and LEA's Determination

The Falcon Refuse Center Transfer Station is a 5.7 acre transfer station located at 3031 East I Street in Wilmington, California.

On December 17, 2019 the LEA received from Falcon an application for a RFI amendment to update the information in the facility's RFI to reflect current conditions. Information on termination of the mechanical sort line, addition of building diagrams and update contact information were included in the modified TPR.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on January 14, 2020.
