Description of Project and LEA's Determination

The Hollywood Street Maintenance District Yard Transfer Station is an approximately 1.03-acre transfer station located at 6640 Romaine Street in Los Angeles, California.

On April 10, 2018 the LEA received from the Bureau of Street Services an application for a Registration Permit with updated hours and contact information.

The LEA finds that the proposed change is exempt from CEQA because the project will not have a significant effect on the environment, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. Therefore, the LEA has issued a Registration Permit on May 1, 2018 to the Bureau of Street Services to continue operating the medium volume transfer station.
