#### **DUTIES**

A Mechanical Engineering Associate performs professional mechanical engineering work in the preparation of plans, designs, specifications, reports, estimates, recommendation of awards, studies, quality assurance programs, safety and health testing, and in research, testing and inspection activities related to the manufacturing, construction, installation, operation and maintenance of mechanical equipment and systems, or checking mechanical systems of buildings for code compliance and operation and maintenance feasibility; may perform code enforcement functions relating to design and specifications of plumbing, mechanical and elevator installations and related equipment approval; and does related work.

#### REQUIREMENTS/MINIMUM QUALIFICATIONS

- A Bachelor's or Master's degree in engineering from an accredited college or university, which includes at least 24 semester units or 36 quarter units
  of core courses in mechanical engineering; or
- 2. Certification as an Engineer-In-Training recognized by the State of California Board for Professional Engineers, Land Surveyors, and Geologists; or
- 3. Registration as a Professional Engineer with the State of California Board for Professional Engineers, Land Surveyors, and Geologists.

#### PROCESS NOTES

- 1. Applicants who are within nine months of graduation from an accredited college or university may apply. However, you cannot be appointed until you have completed all your course work, including the 24 semester units or 36 quarter units described in Requirement No. 1.
- 2. An application and a Supplemental Form must be completed. Applications and Supplemental Forms will be available through the recruiters.
- 3. Candidates filing under Requirement No. 2 or No. 3 must list their Engineer-In-Training (EIT) certification number or Professional Engineer (PE) registration number on the Supplemental Form, question # 1. At the time of appointment, candidates must submit to the department which appoints them, verification of their EIT certification or PE license.
- 4. Appointments will be made to temporary training positions in accordance with Section 5.30 of the Rules of the Board of Civil Service Commissioners for a maximum duration of three years. In order to successfully complete the temporary training period, new appointees must obtain their Engineer-In-Training (EIT) Certificate within three years. New appointees who do not successfully complete the temporary training period will be terminated from the class.
- 5. Some positions may require a valid California driver's license. Candidates may not be eligible for appointment to these positions if their record within the last 36 months reflects three or more moving violations and/or at-fault accidents, or a conviction of a major moving violation (such as DUI).
- Please note that qualifying education must be from a college or university accredited by a City of Los Angeles recognized agency. A list of approved

- 7. Candidates completing the exam process will be contacted by the Personnel Department to provide required proof of qualifying degree.

#### WHERE TO APPLY

- 1. Make an appointment through the placement office of the school with which you are affiliated as a student or alumni (if allowed by the school) to interview with the City of Los Angeles recruiters should they visit your campus.
- 2. Applications and Supplemental Forms will be available through the recruiters.
- 3. Those individuals who are not currently affiliated as a student or alumni with participating schools may participate in the examination when applications are accepted through the City's on-line application process. If the examination is not open for filing at the time of your visit, you are encouraged to complete and submit a notification card by visiting the website at <a href="https://www.governmentjobs.com/careers/lacity/classspecs">https://www.governmentjobs.com/careers/lacity/classspecs</a> so that you may be advised when applications will be accepted.
- 4. Applications and Supplemental Forms may be periodically accepted at alternative locations when the City participates in special recruitment events, job fairs, or career expos. For those special events, any special application or testing procedures will be explained directly to event participants.

#### APPLICATION DEADLINE

For administrative purposes, filing may close periodically and reopen the following day. This examination may be closed without prior notice at any time after a sufficient number of applications have been received.

## SELECTION PROCESS

The examination will consist entirely of an evaluation of professional and personal qualifications by interview. In the interview, the following competencies may be evaluated: Mathematics; Judgment and Decision Making; Self Management; Teamwork; Oral Communication; Project Management; Job Knowledge, including knowledge of: engineering economics used to analyze proposals relating to new projects, betterments, and maintenance; software applications used to perform calculations, organize data, or create graphs; the principles and practices of fluid mechanics, including fluid statics and fluid dynamics; thermodynamics, heat transfer, and combustion sufficient to analyze mechanical systems; machine design, stress analysis, and metallurgy sufficient to determine the proper selection and application of equipment and materials; psychometrics, including the application of psychrometric charts; the principles of process instrumentation and controls, such as sensors and controllers; chemistry as it relates to air and water quality; applicable provisions of federal, state, and local laws, rules, and standards relating to licensing and safety in the design, layout, and operation of mechanical equipment and facilities; operating and performance characteristics of a variety of mechanical equipment components and systems; and other necessary skills, knowledge and abilities.

- 1. This examination is based on a validation study.

You may take the Mechanical Engineering Associate interview only once every 365 days from the date you were last added to the eligible list or when you were interviewed, whichever date is more recent. If you have taken the Mechanical Engineering Associate interview in a campus environment with any City of Los Angeles department or DWP, a special recruitment event, or during an open filing period in the Personnel Department or have interviewed for this position within the last 12 months, you may not file for this examination at this time.
- 4. Candidates may be offered a conditional job offer on the day of the interview. If this offer is accepted by the candidate, the candidate's name will be provided **only** to the department that extended the job offer for hiring purposes.
- 5. Your name may be removed from the open competitive list after twelve months.
- 6. Your rank on the employment list may change as the scores of candidates from other administrations of this examination are merged onto one list.
- 7. At the time of the interview, you must present a valid, State or Federal issued photo identification card.
- 8. Applications are accepted subject to review to ensure that minimum qualifications are met. Candidates may be disqualified at any time if it is determined that they do not possess the minimum qualifications stated on this bulletin.
- 9. A final average score of 70% is required to be placed on the eligible list.
- 10. In accordance with Civil Service Rule, Sec. 4.24, review periods may be combined. Candidates in the examination process may file protests as provided in Sec. 4.20, 4.22 and 4.23 as applicable and within the required time frame; however, the Personnel Department may respond to and resolve protests prior to the establishment of the eligible list.
